A motion was made by Mary Ann Micheletti and seconded by Duke Levari to pay all bills. Roll Call: L. Burshtin - Yes, M. Burshtin - Yes, Levari, Jr. - Yes, Levari III - Yes, Micheletti - Yes. Motion was approved.

<u>Old Business:</u> Michael Burshtin reported that no information has been yet received from Engine Bay Floors regarding the red paint color mismatch of the warranty repair of the bubbled truck bay floor coating. There has been no warranty response yet from Rosenbauer regarding the peeling paint around the rear door latches on Tanker 12-19.

<u>New Business:</u> Buena Vista Township Clerk Lisa Tilton and Buena Vista Township EMS Chief Soren Hudyma gave a presentation of the current status and future plans for the BVT EMS, and future budget plans. As discussed at meetings a year ago, the EMS is now transforming to a paid staff and has instituted soft billings of insurance claims using a billing service. There has been a significant improvement in run coverage. However, the current Covid-19 virus situation has greatly affected the 2020 financial expectations. Vehicle breakdowns, NJ State restrictions limiting the ability to transport patients, and extremely high costs for PPE and disinfecting equipment are negatively affecting both income and expenses. The EMS is now providing monthly run documentation financial statements to the Fire District, and have been audited by the Township. While the Township is greatly increasing its funding to the EMS as rapidly as possible, it is anticipated that Fire District funding will still be needed on a decreasing level for the next two years. The EMS is proposing that Fire District 1 provide \$25,000 for 2021 (\$5,000 reduction from 2020) and \$20,000 for 2022, with no Fire District funding needed thereafter. All Fire District funding would be placed in the EMS capital reserve fund. The Fire Commissioners discussed this proposal, and were generally satisfied to see that the Township and the BVT EMS have now come up with a practical path forward, and that the EMS has significantly improved their run assignment coverage, and the following resolution was offered:

<u>Resolution 2020-13</u>: (BVT EMS Funding) - A motion was made by Duke Levari and seconded by A.J. Levari that the Fire District 1 fund the Buena Vista Twp EMS in the amount of \$25,000 for 2021 and \$20,000 for 2022, with no funding thereafter. Roll Call: L. Burshtin - Yes, M. Burshtin - Yes, Levari, Jr. - Yes, Levari III - Yes, Micheletti - Yes. Motion was approved.

Treasurer Lynn Burshtin reported that proposals were received for preparation of the 2020 audit and 2021 budget from Matthew J. Preziosi of Preziosi Accounting Services, for the same cost as last year.

<u>Resolution 2020-14:</u> (Auditor) - A motion was made by Michael Burshtin and seconded by Duke Levari to authorize the Treasurer to award a professional services contract without competitive bidding pursuant to N.J.S.A. 40A:11-4 and 40A:11-5(1)(a)(I) to the firm of Preziosi Accounting Services, LLC for the time period of November 2020 until October 2021, for the preparation of the 2020 audit and the 2021 budget, at a cost not to exceed \$4,400.00. Roll Call: L. Burshtin - Yes, M. Burshtin - Yes, Levari, Jr. - Yes, Levari III - Yes, Micheletti - Yes. Motion was approved. The Secretary will arrange for publication of a legal notice of contract award without competitive bidding.
