<u>Review of Prior Meeting's Minutes:</u> The minutes of the previous meeting were reviewed. A motion was made by A.J. Levari and seconded by Duke Levari to approve the minutes as presented, and all members present voted in the affirmative.

A motion was made by A.J. Levari and seconded by Mary-Ann to pay all bills. Roll Call: L. Burshtin - Yes, R. Knapp - Yes, Levari, Jr. - Yes, Levari III - Yes, Micheletti - Yes. Motion was approved.

Old Business: Secretary Randall Knapp reported the American Rescue Plan grant is still under review.

<u>New Business:</u> Treasurer Lynn Burshtin noted that we were operating under a temporary budget in accordance with Resolution 2023-25. The final adopted 2024 budget was not yet returned from the NJ DCA. The records are being assembled for the 2023 audit.

Secretary Randall Knapp reported one of our new SCBA broke and has been repaired and returned by Dival.

Tanker-Pumper fire apparatus: The Secretary reported on the continuing development for the last several months by a joint Fire Commissioner/Richland Fire Company truck committee to develop a Tanker-Pumper fire apparatus specification for replacement of the 2000 Pumper 12-10. A larger tanker-pumper of approximately 1500 gallon capacity is needed, with the capability of also serving as a first-out pumper/rescue apparatus. It has been determined that the vehicle costs will be in the general range of \$995,000. with another approximately \$75,000 required to outfit the truck with hoses, nozzles, air packs, etc. in accordance with NFPA requirements, for an approximate total of \$1,070,000. In meetings with our attorney regarding the purchase, he advised that this purchase should be placed by Resolution upon the Annual Election ballot in February 2024 as a Public Question to approve the purchase of the fire apparatus, along with authorization for use of Restricted Funds and for financing. A vehicle purchase down payment using the currents funds on hand could be made during 2024 if desired. After voter approval is obtained, price quotations must be obtained for the desired vehicle. Once the price has been determined, competitive rates for the necessary financing must be solicited, and this must then be presented to the Local Finance Board for their authorization to proceed. Only after Local Finance Board approval is obtained, can a purchase award be made. The following resolution was then offered:

Resolution 2024-01: (Tanker-Pumper Public Question) - A motion was made by Randall Knapp and seconded by A.J. Levari to authorize the Fire District officers to place a Public Question upon the February 2024 annual election ballot, if Fire District No. 1 of Buena Vista Township be authorized to expend up to \$995,000. of capital appropriation funds (including restricted and unrestricted funds) to purchase and furnish a Tanker-Pumper fire apparatus, and also be authorized to issue financing as may be required, such as Bonds and Bond Anticipation Notes. Roll Call: L. Burshtin - Yes, R. Knapp - Yes, Levari, Jr.- Yes, Micheletti - Yes, Levari III - Yes. Motion was approved. The Secretary will include this Public Question in publication of the required legal notices for the annual election on February 20, 2016.
