The January 2019 meeting of the Board of Fire Commissioners of Buena Vista Township Fire District No. 1 at the Richland Fire House was called to order at 7:30 PM by Chairman Mary Ann Micheletti-Levari . Review of Prior Meeting's Minutes: The minutes of the previous meeting were reviewed. A motion was made by Mary Ann Micheletti and seconded by Lynn Burshtin to approve the minutes as presented, and all members present voted in the affirmative.

The Treasurer noted that we were operating under a temporary budget in accordance with Resolution 2018-22. A motion was made by Michael Burshtin and seconded by Mary Ann Michael tit to pay all bills. Roll Call:

Old Business: Treasurer Lynn Burshtin reported that the final adopted 2019 budget was not yet returned from the NJ DCA. We are still awaiting receipt of the signed agreement with Buena Vista Twp. EMS. The three Narcan drug overdose kits have been received.

New Business: The Secretary reported that the 2019 fleet insurance cards have been placed in the trucks. Ron Grattini found that the coolant leak on Tanker 12-19 was due to some loose hose fittings, and the inoperative left side power windows had a blown electrical fuse, and both items were corrected. Western Pest Control did an extensive 1-time treatment for mice and spiders in the building, and several mice were already caught. The bottom weatherstrip on the truck bay doors were found to have shrunk several inches, letting in mice and drafts, and will be repaired. All truck rechargeable hand lights have new batteries installed, and one LED light is being returned for warranty repair due to not charging. The cascade system pressure regulator is drifting out of adjustment and will be repaired. All trucks have been outfitted with a basic assortment of hand tools. The furnace air filters have been replaced for the season. Replacement lamps for the obsolete 900 watt lamps on the Engine 12-11 Will-Burt light tower are being researched.

The Treasurer reported that the records are being assembled for the 2018 audit. The Buena Vista Township rabies clinic will be held at the Richland Fire House on Saturday, March 2 from 1 PM to 3 PM.

The Secretary announced that the 2019 annual election will be held on Saturday, February 16, 2019 from 2:00 PM until 9:00 PM in accordance with law. One Commissioner position for an unexpired one year term, and one Commissioner position for a full term of three years will be up for election (the term of office for Mary Ann Micheletti is expiring). The required legal advertisements have been issued.
